**PRIVACY NOTICE: PARENTS** 

Cherwell College Oxford is a "data controller" under data protection law. This means that we are responsible for deciding how we hold and use personal information about you.

Your privacy is important to us and we want to keep your personal information safe. This Privacy Notice tells you how we do that and sets out your rights when it comes to the personal information that we hold about you.

The College only holds the personal information we are allowed to hold about you, and only uses it for limited purposes.

#### WHAT KIND OF INFORMATION DO WE COLLECT ABOUT YOU?

- Your personal information (such as your name, title, addresses, telephone numbers, email addresses, profession)
- Your ID documentation and consent letters in support of your child's visa application and where necessary for the College to comply with its due diligence requirements for UK Visas & Immigration (UKVI)
- Where appropriate, information about your health and welfare, and the health and welfare history of your family
- Bank and financial information, particularly with regard to the payment of school fees or where necessary to comply with UKVI requirements for your child's visa application
- Other financial information in connection with fees in advance payments in accordance with anti-money laundering law
- Information from CCTV cameras when you visit the school site

#### HOW DO WE COLLECT YOUR PERSONAL INFORMATION?

We collect personal information from you directly. This may be through a form, or simply in our day-to-day contact with you (such as emails or verbal conversations).

From time to time we may also collect information about you and your child supplied by others. For example, we may receive personal information about you in admissions forms from your child's previous school or from doctors, professionals or authorities.

The majority of the personal information you provide to us is mandatory, which means that you must provide it to us so that we can provide our services to you and your child. Other personal information you provide to us is optional, which means that you may decide not to provide it to us. We will let you know when the personal information we request is optional.

## WHY DO WE COLLECT YOUR PERSONAL INFORMATION?

We use your personal information:

- 1. to decide whether your child can be admitted to the College (and consider whether concessions or discounts will apply)
- 2. to support your child's learning and education

- 3. to monitor and report on your child's progress
- 4. to make sure your child's health and wellbeing is looked after
- 5. to make sure we provide your child with a high quality of education
- 6. to facilitate the payment of school fees
- 7. to ensure the College complies with the law and meets its legal obligations

#### THE LAWFUL BASIS FOR USING YOUR PERSONAL INFORMATION

Most of the personal information we collect about you is needed to make sure we are able to fulfil our obligations to you under the parent contract. For instance, we require your personal details to fulfil our contractual obligations to keep you informed of your child's health, wellbeing and educational development.

We also use your personal information to make sure that the College is acting within the law and meets its legal obligations.

There are also some situations where we use your personal information for other reasons (these are known as the "legitimate interests" of the College). This will usually be the case when the parent contract we have with you does not apply (or is not yet in place) or when there is no specific law which requires us to use your personal information. For example, we will use your personal information when deciding whether your child can be admitted to the College and when we ask for professional advice from someone outside the College.

We may also rely on your informed and freely given consent to use your personal information.

It is important to be aware that, where appropriate, we also use some sensitive personal information about you, such as your medical and health information. This information is used to ensure your child's welfare and provide us with the information we require to meet your child's specific needs.

## WHO DO WE SHARE YOUR INFORMATION WITH?

We routinely share your personal information with:

- 1. schools and education institutions that your child attends after leaving us
- 2. our local authority
- 3. the Department for Education

We may also share your information with others where we are required or permitted to do so by law, or where we have a legitimate interest in sharing your personal information. This might include the Independent Schools' Inspectorate, the UKVI, the Charity Commission, Ofsted, professional advisers, auditors, or other regulators.

#### HOW SECURE IS MY INFORMATION WHEN OTHERS USE IT?

All our service providers have to take appropriate security measures to protect your personal information in line with our policies. We do not allow our third-party service providers to use your personal data for their own purposes. We only allow them to use your personal data for specified purposes and in accordance with our instructions.

## TRANSFERRING STUDENT, PARENT AND GUARDIAN DATA INTERNATIONALLY

Your personal information may be stored and processed outside of the country where it is collected, including outside of the European Economic Area (EEA).

We will only transfer personal data to a country or territory outside the EEA:

- where the transfer is to a place that is regarded by the European Commission as providing adequate protection for your Personal Information; or
- where we have put in place appropriate safeguards to ensure that your Personal Information
  is protected (for example where both parties involved in the transfer have signed standard
  data protection clauses adopted by the European Commission);or
- the above does not apply but we are still legally permitted to do so, for example if the transfer is necessary for the establishment, exercise or defence of legal claims.

## **INFORMATION SECURITY**

We protect the security of your information.

We have procedures to make sure that your personal information is not accidentally lost and that it is not used, accessed, changed or shared with others without our permission. Your personal information will only be shared with people who need it. They will only use your personal information with clear instructions from us. We will make sure that they treat your personal information as confidential. We have put in place procedures to deal with any suspected data security breach and will notify you and any applicable regulator of a suspected breach where we are legally required to do so.

## FOR HOW LONG WILL YOU KEEP MY INFORMATION?

The College will keep your personal information for as long as it is necessary. When we do not have a lawful reason to hold it, we will delete or destroy your personal information securely. Typically, we will hold your personal information for a period of up to seven years after your child leaves the College or when your child reaches the age of 25 (whichever is later). Some of your personal information will be kept for a much shorter period, e.g. CCTV images and bank account details. However, any of your personal information which relates to incident reports and safeguarding must be kept much longer, as required by the law. In some circumstances we may anonymise your personal information, so that it can no longer be linked to you. If we do this, we may use such information without telling you.

## WHAT ABOUT CHANGING THE INFORMATION THAT WE HOLD ABOUT YOU?

If any of your personal information changes, it is important that you let us know so that we can update our records to keep it accurate.

#### WHAT CAN I DO WITH THE PERSONAL INFORMATION THAT YOU USE?

You can:

- Ask to see your personal information
- Ask for a correction of your personal information to ensure it is accurate
- Ask for your personal information to be deleted
- Object to processing of your personal information
- Ask for us to limit the processing of your personal information
- Request the transfer of your personal information to another party.
